

**The Michael Breed x MorganFranklin Transformation Tuesday Giveaways (the “Promotion”)  
Official Rules

**1. Eligibility:** The Promotion is open only to legal residents of the 50 United States and the District of Columbia (“D.C.”) who: (a) are 13 years of age or older, (b) are located in one of the 50 States or D.C. at the time of entry; and (c) have received an invitation to participate in a “The Michael Breed x MorganFranklin Transformation Tuesday Giveaways” Sweepstakes.
